#### **ABSTRACT**

Safety procedure is very important in doing tourism activity especially when it involved adventure setting. Nowadays, with the cases of COVID – 19 still arising, the concern over safety is high. People are keen to travel after a long restriction because of the pandemic. It is a responsibility to the tourism operator to fulfilled their wants and delivery excellent service quality without compromising safety aspect trough out the whole process. Is tourism operator ready in term of safety procedure in their place? Therefore, this is in line with the aim of this research which to analysed operator readiness towards adventure safety procedure during COVID -19. Rafting can be considered as hard adventure tourism activities in natural setting. It required mental and physical strength. Three objectives have been out lined for this research. First, to identified the factor of safety procedure for adventure activities that has been affected the rafting activities during COVID -19. Second, to examine the factors of rafting operator readiness towards safety procedure during COVID-19. Third, to understand the challenges of adventure tourism operator in providing safety procedure during COVID -19. Qualitative approach was chosen for these research. Data was gathered through researcher observation and interview. Five rafting operators were interviewed using in- depth semi structure question. Data collection then was analyzed using thematic analysis. The finding shows that rafting operator in Gopeng, Perak are ready to serve the tourist. They have prepared what it takes to deliver safe experience to their tourist.

Oleh itu, ia adalah selari dengan tujuan penyelidikan ini dijalankan iaitu untuk menganalisis kesediaan operator pelancongan terhadap prosedur keselamatan semasa COVID-19. Rafting merupakan aktiviti pelancongan pengembaraan yang lasak yang dilaksanakan di persekitaran semulajadi. Ia memerlukan kekuatan mental dan fizikal. Tiga objektif telah digariskan untuk penyelidikan ini. Pertama, mengenal pasti faktor prosedur keselamatan yang terjejas semasa COVID-19. Kedua, mengkaji faktor kesediaan pengendali rafting terhadap prosedur keselamatan semasa COVID-19. Ketiga, untuk memahami cabaran yang di hadapi oleh operator pelancongan dalam menyediakan prosedur keselamatan semasa COVID-19. Pendekatan kualitatif telah dipilih untuk penyelidikan ini. Data dikumpul melalui pemerhatian dan temu bual. Lima pengusaha rafting telah ditemu bual menggunakan soalan separara berstruktur . Pengumpulan data kemudiannya dianalisis menggunakan analisis bertema.. Dapatan kajian menunjukkan pengusaha rafting di Gopeng, Perak bersedia memberi perkhidmatan yang terbaik kepada pelancong.. Merekatelah menyediakan apa yang diperlukan untuk memberikan pengalaman rafting yang selamat kepada pelancong.

#### CHAPTER 1

#### INTRODUCTION

#### 1.1 Introduction

This chapter provides the overall view of the research, which include research background, problem statement, objectives, research question, study are, and scope of study area. The component in this chapter is important for readers to get the general understanding of the focus and the purpose of this study.

## 1.2 Research Background

The COVID-19 pandemic has had a particularly severe impact on the tourism industry. The statistics are alarming after a few years of the outbreak. According to the United Nations World Tourism Organization, tourism destinations received one billion fewer foreign visitors in 2020 than in 2019. A sharp drop in international travel resulted in a loss of almost USD 1.3 trillion in export income, more than 11 times the loss seen during the previous economic downturn in 2009. A total of 100 to 120 million tourism jobs were jeopardised, the majority of which were in small and medium-sized businesses. The COVID-19 epidemic has caused uncertainty and spillover effects in practically all industries, and the lingering crisis in worldwide tourism is a major concern. The tourism industry contributes to the country's economic growth, accounting for 10.4% of GDP and 10% of global employment (Joppe, 2020).

Adventure tourism is a popular form of tourism that attracts a huge number of visitors. There are destinations that meet the needs of adventure tourists while also being popular for leisure and/or relaxation. Adventure tourism has grown in popularity in today's worlds, particularly among those affluent travellers seeking an adventure rather than simply sitting and relaxing in a destination.

The phrase "adventure" refers to an activity that creates a sense of personal thrill. Adventure tourism is a fast expanding tourism offering that encompasses activities like hiking, camping, river rafting, backcountry bicycling, and many others.

Due to COVID-19, most of the countries implemented travel restriction in order to control the spreading of the virus. Border closure implemented by most of the countries had badly impact tourism operator. People will always be wanted to travel once the pandemic is over. Once the economic is open to operate as usual, people who unable to travel for quite some time will take this opportunity to start the gear. Today's travel main concern is about safety procedure or so call as new norm of traveling to ensure they have safe travel experience. All sectors not only tourism is discussing this topic. Adventure tourism operator such as rafting operator need to strengthen the strategy on safety precaution measure to ensure the safety and health of the tourist is being taken care of. This is very important to increased tourist trust and confident to take part in tourism activities.

Health, safety, and trust are crucial in this new century, according to the World Travel and Tourism Council (WTTC) Report 2020. In the short to medium term, consumer behaviour will be guided by personal experiences, fears of being stuck in another nation, and concerns about distancing.

Social distancing measures and strengthened safety protocols are two of the most typical precautions that all adventure travelers want from their final destination. Besides that, the survey indicated that adventure travellers in the United States are more concerned about their safety when visiting a popular or crowded metropolis than when visiting a small town, backcountry, or national park. This is an excellent opportunity for adventure activities to take place in order to fully satisfy their desires.

This is in line with the aim of this research which to analyzed operator readiness towards adventure safety procedure during COVID- 19. Gopeng, Perak is the selected area to conduct the research as this area is well known for rafting activity not only in Malaysia but also internationally.

## 1.3 Research Gap

Adventure tourism has been a topic of a research since years ago. Previous research has been focusing on tourist safe need, safety tips, risk management, tourist motivation in pursuing adventure activity, Challenge and prospect of adventure tourism and many more. Less research has been made focusing on operator readiness towards adventure safety procedure during COVID-19. This research will focus on rafting activity in Gopeng, Perak. What are the precaution safety procedure that operator apply to enhance tourist trust and confidence while doing the activity.

#### 1.4 Problem Statement

Prior to the epidemic, adventure travel was thriving all over the world. In 2018, the worldwide adventure tourism market was worth USD 586.3 billion, with a forecast of USD 1,626.7 billion in 2026. (Allied Market Research, 2020). The development of the travel and tourism industry encourages the market need for adventure tourism to rise. Adventure tourism refers to vacationing or exploring with a certain amount of danger, and it includes activities such as climbing, hiking, caving, rafting, and other similar activities.

After the pandemic hit the world started late in December 2019, the movement of people has been restricted. Traveling has become more challenging due to the concern over the spreading of COVID – 19. Today, people around the globe get used to the term 'new norm' of life. Social distancing, hand sanitizing and wearing mask in a public area are becoming normal almost every way. This new norm is also applicable in adventure tourism. Health and safety procedure are the important element when travelling. Indulging in rafting activities for instance, not only it is a high risk activities, but also involved operator readiness to align with the safety procedure during COVID-19.

Traveling has become more challenging and more people nowadays are keen to travel to a remote area in order to reduce the risk of getting affected by the virus. Health and safety procedure are the important element when travelling. Despite normal health and safety procedure are applicable for all recreation activities including adventure tourism, the aspect of operator readiness in fulfilled this requirement is still uncertain. Therefore this research will try to fill the gap and look into how COVID - 19 changed the safety procedure and how ready tourism operator tap with the changes.

This research will try to analyzed three aspect of operator readiness as the provider of the service to ensure all safety procedure meet tourist expectations. These include operational and staff preparedness, delivering safe experience and ways to gain

tourist trust and confidence during the pandemic (UNWTO,2020). Gopeng, Perak is the study area for conducting the research as this area is well known as white water rafting activity among Malaysian as well as international tourists.

## 1.5 Research Aim and Objective

The aim of this study is to analyzed adventure tourism operator readiness towards safety procedure during COVOD-19. The objectives of the study are as below:

- 1) To identify the factors of safety procedure for adventure activities that has been affected the white water rafting activities during COVID -19.
- 2) To examine the factors of white water rafting operator readiness towards safety procedure during COVID-19.
- 3) To understand the challenges of adventure tourism operator in providing safety procedure during COVID -19.

## 1.6 Research Question

The research questions for this study are as follows:

- 1. What are the factors of safety procedure for adventure activities that has been affected the white water rafting activities during COVID -19?
- 2. What are the factors of whitewater rafting operator readiness towards safety procedure?
- 3. What are the challenges of adventure tourism operator in providing safety procedure?

## 1.7 Study Area

Perak, is a popular tourist destination for both domestic and international visitors. Domestic tourists visiting Perak recorded about 21.1 million, according to a 2019 study by the Malaysian Department of Statistics. From 2012 to 2014, the state of Perak had the greatest number of domestic tourist arrivals in the country (Ili Aqilah, 2015). Perak also ranked 5th in term of domestic tourism receipts amounting to RM 7.8 billion in 2019.

Perak, a state in Malaysian with a wealth of tropical natural resources, as well as a rich history and culture. It is Peninsular Malaysia's second-largest state (21,035 km2), with many natural tourist attractions such as White-Water Rafting, Gua Tempurung, Peninsular Malaysia's largest limestone cave; Royal Belum State Park, Peninsular Malaysia's oldest virgin rainforest; and the Lenggong UNESCO World Heritage Site (Rasoolimanesh, Dahalan, & Jaafar, 2016). Perak is still one of Malaysia's greatest tourist spots today. On top of that, Perak was chosen as one of the top ten destinations in the "Best in Travel 2017" category by the famous publication Lonely Planet (Nuradzimmah, 2016). According to department statistics of Malaysia (2019), Perak ranked number five in term of receiving domestic tourist in 2019. About 21.1 million of domestic tourist recorded in 2019. This indicates that Perak is among the top tourist destination in Malaysia.

Gopeng used to be known for its tin mining business, but now it is known for eco-tourism and outdoor adventure. Jungles, rivers, waterfalls, mountains, cavems, ponds, and villages surround the town of Gopeng. As a result, Gopeng is a fantastic adventure location. The Kampar River's clean water (Class I-III) is ideal for anyone who is physically fit and looking for a little technical experience while rafting safely.

Gopeng also a house of rafting operator that has been proven as one of the world class white water rafting organizer. Kampar River Festival 2019 was a biggest white-water festival in Malaysia, endorsed by the International Rafting Federation

(IRF) and Indonesia White Water Federation (FAJI). Received about 400 participant around the globe.

This is the reason why this research being conducted in Gopeng, Perak. It will create value added to the area once the research being published. Therefore, will further promote Gopeng as a destination of choice among the rafting community throughout the globe.

## 1.8 Scope of Study

COVID-19 has changed the way of travel. New norm of traveling has been introduced to ensure tourist is safe while doing activities. Tourism operators must take precautions to re-establish trust and confidence with visitors through efficient communication and marketing, informing them of the protocols in place and the assurances that are available to keep them safe. World Travel and Tourism Council (WTTC) 2020, has released worldwide norms for the new normal, specifically for adventure tourism. As travel and tourism progresses from crisis management to recovery, the guideline aims to establish industry best practises. It also emphasises the importance of putting the safety, health, and security of travellers and the travel and tourism workforce at the forefront of global protocol development.

This research will be focusing the readiness among rafting operator in Gopeng Perak in coping with these protocols. There are three aspect that will be look into. The elements include operational and employee preparedness, providing a safe experience, and re-establishing trust and confidence. As adventure tourism businesses reopen, they should make sure they have the resources to improve operational quality and delivery, as well as skilled personnel to design and execute operational plans. It's also critical for adventure tourism operators to provide a safe environment for their employees and visitors by improving cleanliness and hygiene standards. Transparency and communication with guests will result in increased trust and confidence. Safety procedure that affected rafting activity also will be identify. Among the factor that will look into are hygiene procedure, rafting capacity, transportation, screening procedure as well as social distancing.

## 1.9 Significance of Study

COVID – 19 has reported the first case in Malaysia in January 2020. Since then the number of cases increasing day by day. To overcome this pandemic from spreading, Malaysia Government had enforced Movement Control Order (MCO) which restricted movement of people. All business except essential service has to stop their operation. Tourism is one of the sector most affected by the pandemic. The outbreak of COVID-19 has exposed a major risk to Visit Malaysia 2020 (VM2020) campaign as 50% of Malaysia's tourists are originate from Singapore and China. The increasing cases of COVID-19 in both countries has led to the cancellation of many tours, which has already led to a large drop in the number of tourists to Malaysia.

Once the MCO ended tourism operator start to receive customer but with new norm. Hand sanitizer, wearing mask, social distancing and temperature check has become new way of life and people get used to it. Rafting activity, for instance, is one of adventure tourism that received huge demand. Rafting operator need to be ready with the safety procedure to ensure tourist get excellent service and they are safe through out the activity. This research aim is to analyzed operator readiness towards safety procedure during COVID – 19. Therefore the finding of the research can be used as a benchmark or guideline for other tourism operators in preparing their safety procedure. Besides that, the finding will also increase tourist confident to indulge in rafting activities.

## 1.10 Study Approach




Figure 1.1 Study Approach

## Stage 1 & 2 Preliminary Study

The early study in stage 1 contain identification of issue and problem of the research. After that, continued with research objective and research objective which based on the problem statement and what to achieved from the research. Literature review related to adventure tourism, safety procedure, operator readiness and challenge operator faced during the pandemic. Second, Relevant case study from related journal also gathered. Data were based on secondary source such as report, publication and previous research.

Stage 3 is data collection phase and data analysis, and the research instrument that were applied are as follows;

Primary data – This research using qualitative approach. Primary data collected from in depth interview with rafting operator in Gopeng, Perak..

Secondary data – All secondary data captured from journal, book and article The data was carried out using thematic analysis to analysis the data. The result of the study will provide the data for next stage. Data collection and analysis took about four months. Opinion and view from the respondent will be gathered to match the basis literature and achieve the objective of the study.

## **Stage 4 – Conclusion**

The final stage is the conclusion of the finding or outcome of the research. It is expected that the explanations of the findings would be relevant to the research questions topics, hence achieving the research aim and objective.

## 1.11 Limitation of Study

This research conducted qualitative analysis. The interview session very time consuming. Researcher has to search for the correct and available individual that can be a respondents. In addition, the finding of this research are based on interview of 5 respondents of local operator and not generalized in the views of all operators. Besides that, there are limited sources of literature review related to operator readiness because mostly are focus on community readiness and not to tourism operator.

This chapter has presented an introduction to the thesis. It has outline the background of the research, problem statement, stated the research objective and research question. The significance of the research has also been indicated, the initial conceptual framework has been introduce and lastl, summary of the overall research will be provided.
