

The Role of Institutions in Promoting Citizenship Values: A Bibliometric Analysis

The purpose of this study is to examine the volume of intellectual output on the topic of citizenship value in the Scopus database between 2012 and 2021. The results indicated that 3,617 studies had been conducted. Utilizing bibliometric search indicators. The United States and the University of Georgia have shown the most interest in publishing in this field over the past decade. Although the intellectual output on good citizenship in the Emirates was not a study and conference work received the highest percentage, it was not included in SQUES. This may be due to the absence of stringent standards when publishing working papers at conferences, as opposed to scientific journals, and the existence of institution-specific journals. We also discover that a large number of authors, such as the Multidisciplinary Digital Publishing Institute (MDPI) and Frontiers Media S.A. (APA), are interested in this type of research, and that the term "good citizenship" is primarily used in the social sciences and various sciences. The absence of a large number of studies in Arab countries is the cause; these studies may have been published in a language other than Arabic, and SCOPUS does not list them. The research provides a guide to the research process for researchers in the field of research.

Introduction

Institutions nowadays face the issue of ethics and values as a major issue in all their fields, at the national, regional, and global levels, as those interested in values and their system are clamouring for the need to reshape them for the contemporary man; because random material and individual values have come to dominate behaviour, with a clear disregard for establishing standards of correct moral behaviour as standards of right, virtue, and charity. (The Arab Magazine, 2017) Citizenship is the cultural identity of the individual, which distinguishes him with distinct traits and characteristics from the citizens of a different country. The cultural components of good citizenship include faith, thought, literature, society, the arts, and so on. Good citizenship is one of the decade's most intriguing concepts.

As a result, this paper will discuss the topic and analyse the output of scientific thought. in good citizenship from the Scopus database, in an effort to expand the available literature on the subject. The Scopus database is among the largest indexing and extraction databases.

This database contains articles from scientific journals, books, and proceedings of conferences. It encompasses all scientific disciplines, particularly the social and human sciences. The search is based on chronology, authors, co-authorship, geographical distribution, and educational institutions, and to achieve this objective, bibliometric search indicators included in the Scopus database over the past decade from 2012 to 2021 were used. Using the (Vosviewer) programme to take advantage of the similarities. There were a total of 1,134 publications from the Scopus database that were analysed. This study provides a quantitative examination of citizenship. The research will focus on the analysis (Bibliometrics) of research published in the Scopus database in the field of study. To assess academic outcomes in the area of good citizenship. This study will also demonstrate the significance of institutions in promoting good citizenship. Given the preceding, the following question can be posed:

1. What is the distribution of the most publications in citizenship values by years in the past decade?

2. What are the most relevant journals and authors on citizenship values by years in the past decade?

3. What are the most productive countries in the field of citizenship values by years in the past decade?

4. What are the most searched keywords for citizenship values in the past decade?

Methods and Materials

Because of the significance of the topic, the purpose of this review is to examine the collection of studies that have been carried out over the past ten years in an effort to determine the part that institutions play in encouraging responsible citizenship. According to Tahtawi (1996, 25), "the most important and valuable thing that any educational system offers to its children is the value of good citizenship that shapes its activity and behaviour, which leads to the integration of the individual and the balance of his behaviour, and his ability to resist negative and deviant behaviours, and the balance between his personal interests and the interests of society, and the preference of the public interest over the private";; "the most important and valuable thing that any educational system offers to its children is the value of The term "bibliometrics" is defined as the "analysis of the data related to the document to understand

As can be seen in Figure [1], the research accessed the 10 most influential articles on the topic of responsible citizenship by drawing on relevant publications found in the Scopus database. During the test that was carried out on October 28th, 2022, a keyword search was performed either in the section titled "Title" or "Abstract," or by selecting the "Subject" option. Articles written in English and those that were freely available to read online were taken into consideration for inclusion in the study. The concept of "good citizenship" has been utilised in a number of phrases and keywords that evoke it.

As can be seen in Figure [2], we obtained the journals that discussed the role of institutions in cultivating responsible citizenship by using Scopus. We performed a manual check to exclude irrelevant publications based on the criteria shown in Figure [2], and the total number of publications was "3,617." In order to ensure that the publications that were analysed were of sufficient quality, we carried out this check. In this manner, the total number of publications, "1,984", was not altered. Figure [3] also provides a visual representation of the research framework for analytical studies. The programme VOSviewer, which is a type of analysis that analyses data in the form of relationships (between the publisher, the country, and the terms most used in the publications), was also used in this research. VOSviewer is one of the programmes that is widely used in the visualisation of bibliometric networks. An initial plan was devised, which can be seen illustrated in the following form:




Figure 1: PRISMA Framework

As a result of what was previously placed in the table, and when loaded into databases, it is entered into the Excel programme to extract results related to the production of publications, and the trend of chronological development in publications of citizenship values; The purpose of the study is to reveal the file of studies on the role that institutions have played in promoting good citizenship over the course of the past ten years.

Results




Figure 2: distributions by years






Figure 4: journals and authors most relevant to the research

According to the table listing the top 10 authors, journals, total citations, and total publications, the total number of citations for his work in Frontiers in Psychology is 14927, and he has 59,147 total publications. Additionally, the number of citations for his work in other journals is 179. According to Figure 4, which classifies papers according to their primary function, the article was the most common document category, accounting for 84 percent of responses, followed by book chapters.

What are the most productive countries in the field of citizenship values by years in the past decade? To answer this research question we developed the following chart.




Figure 5: the most leading countries in the research topic




Figure 6: the most leading countries based on Vosviewer




Figure 7: the most used keywords

What are the most searched keywords for citizenship values in the past decade? To answer this research we used VOSviewer as illustrated in figure 7 below:

Establishing an ethical observatory within each administration in order to evaluate the effectiveness of institutions in terms of the ethical dimensions and practises that are present in those institutions.
